On January 1, 1962, the Academic Council of the University of Delhi decided that the outer circle in the logo would carry the name of the University in whole. The motto of the University would be in black color, the Elephant and Lotus would be gold in colour, the river in dark blue and the book in white.

Shivaji College, a constituent College of University of Delhi is governed by Delhi Administration. It is a co-educational institution offering various courses in Humanities, Science, and Commerce at undergraduate and postgraduate level. The College has completed more than 50 years in the area of education. We soared new heights in the academic year 2015-16 as our college was accredited with "A" Grade by the prestigious National Assessment and Accreditation Council (NAAC). This achievement summarizes the struggle and hard work contributed by the Shivaji College family over the years.

Reputed Faculty

The College has an energetic and vibrant faculty that encourages students to go beyond textbooks and acquire experiences that will enable them to become culturally sensitive and socially responsible individuals. We aim towards a holistic development of students thereby nurturing them in a way that they contribute to the well-being of society and nation. The Internal Quality Assurance Cell of the college ensures quality teaching and monitors the progress of students.

Library

Shivaji College Library is automated with over 67000 books of various disciplines. The Library subscribes to a total of 50 newspapers and magazines and has a rich collection of diverse reference works such as encyclopaedias, dictionaries, atlases, yearbooks, *etc.* The Library also provides access to about 6000 e-journals and 97000 thousand e-books through N-LIST Programme of INFLIBNET and a host of high quality electronic databases subscribed by Delhi University Library System (DULS) for its users. There are two air-conditioned reading halls in the Library, one each for students and teachers, wellequipped with computer and internet facilities. The Online Public Access Catalogue (OPAC) is in place to ensure easy access of books to the users.



For differently abled students there are several facilities such as Braille kits with CD's, over two hundred books in Braille, laptops, Angels, Lex software and Tape- recorders etc., in the library.

Sports and Games

Shivaji College has one of the largest sports playfield amongst the colleges of Delhi University. Adequate facilities for games such as cricket, football, basketball, chess, table tennis, athletics, softball and baseball are provided to the students. Associated infrastructure facilities such as changing rooms and store rooms are also available for the students. The college sports teams participate in inter-college and inter-university tournaments. The college has been visited by various national and international players of repute who have encouraged students to work hard and excel in sports and games.



College Cafeteria

The cafeteria is the most popular joint amongst the students to hang out and discuss everything ranging from classes and music to movies. Great and hygienic food, affordable prices and a good ambience makes the college canteen the most frequently visited place. The Lipton kiosk and Mother Dairy booth within the college premises also provide additional choices to the students by offering them fresh snacks and drinks at reasonable prices.

Laboratories

The college is equipped with modern and efficiently managed laboratories for science courses offered such as Physics, Chemistry, Zoology, Geography and Botany. Four air-conditioned computer science labs provide access to sophisticated softwares and high speed internet connectivity to students and staff.



Magazine

The college magazine "Shivraj" acts as a platform for young minds to share their experiences, thoughts and opinions. It reflects the ideological bent of the college youth. The magazine publishes contributions from students and teachers in English, Hindi and Sanskrit. Articles, poems, essays and stories display the literary skills of students across various disciplines. It is eagerly looked forward to by the students because it is a cherished record of their vibrant college life.

College Auditorium

The auditorium is well-equipped with a state of the art audio visual system, projector and stage lighting arrangements. It is spacious and fully air-conditioned with a seating capacity of 400. It is the centre for various extracurricular, cultural and educational activities like seminars, talks, debates, plays, moviescreenings and departmental festivals. For many students the auditorium provides the stage where they overcome their stage-fright and learn to give the first performances of their college life.

Convenient location

Situated off the ring road, the College is very close to the metro station. Centrally located and surrounded by various public amenities like hospitals, restaurants and shopping centers, the College is well connected to airport and railway stations as well.

Research Avenues and Opportunities

Research in inter-disciplinary and trans-disciplinary area through the medium of Innovation Projects and classroom interaction (I.E.) is promoted. The College takes pride in offering well equipped science and computer labs. Free Wifi login ensures that the students access e-journals and online databases subscribed by the University of Delhi.

Student Information System

Online access to monitor attendance and internal assessment has been provided through the portal www. shivajicollegeia.com.

Harmonious Environment

The college authorities have installed a complaint box for girl students outside the Principal's office where grievances related to sexual harassment, ragging and eve-teasing can be submitted. The College campus is a smoke-free and vehicle free zone which provides a healthy environment for students' well-being

Banking Facility

Central Bank of India has a branch within the college premises. The staff and students can open accounts as well as avail other banking facilities.

Xerox Facility

There is a Xerox centre within the college where students can avail photocopying facility and book binding facilities at their convenience.

World University Service (WUS) Health Centre

There is a WUS Health centre in the college premises to assist students and staff and provide them with basic medical care. Students can avail a health card at the cost of 120/- per year. College has made a provision for Accidental/Life Insurance Policy (Rs. 1 Lac) for students. A counsellor is also available in the college to help students deal with their socio-psychological problems.

National Cadet Cops (N.C.C.)

The N.C.C. Unit of Shivaji College is a group of motivated and trained youth that exhibit leadership qualities. The Boys' Wing is attached to the 2nd Delhi Battalion, New Delhi and the Girls' Wing comes under 7th Delhi Girls Battalion, Kirti Nagar. Our cadets have won many prizes at Combined Annual Training Camp (CATC) and brought laurels to the college. Cadets can also attend national level training camps like Republic Day Camp, Army Attachment Camp, Thal Sena Camp, Trekking and Parasailing. The N.C.C. also serves as a catalyst for joining armed forces as certain vacancies in IMA and in OTA are reserved for N.C.C. 'C' certificate holders and they are eligible to face S.S.B. interview directly. Students who are medically fit and desirous of joining N.C.C. Training are enrolled upon submission of an application at the beginning of the session to the N.C.C. in charge.



National Service Schemes (N.S.S.)

The NSS Unit of Shivaji College is an active and vibrant unit. The team of enthusiastic students has made possible various projects and events. Project AKSHAR aims to encourage paper conservation and provides livelihood to differently abled women. Apart from this, Anti-Tobacco Campaigns, Cancer Awareness Programmes, Blood Donation Camps, Health Check-ups, Voter Awareness Programmes and Phenology Studies are also organised at regular intervals. A mock drill was conducted to train the students regarding safety measures to be taken at the time of calamities like earthquakes.

Eco-Club

The Eco-Club of Shivaji College is run in coordination with the Department of Environment, Govt. of Delhi. It plays an important role in creating Environmental awareness amongst the young generation by developing a multi-dimensional approach towards conservation, preservation and promotion of environment. One World, One **Environment** is the slogan of the club and its aim is to practice the 3Rs: Reduce, Reuse and Recycle. As a part of this agenda, it organises annual excursions to make students aware about the human impact on our environment. In addition to this, the club engages in projects such as Kitchen Gardening, Herbal Gardening, Solar Panel Installation (in progress) and Rain Water Harvesting. Several drop boxes are placed in the college campus to collect paper and e-waste.

Women Development Cell

The college has a Women Development Cell for advocacy of gender issues and justice. A primary objective of the Cell is to create a more inclusive, tolerant and gender sensitized community within campus as well as in society. International and National level events like self-defense training workshops, debates, talks by eminent personalities, health camps and various competitions are organized regularly. Any student can join this cell and participate in its activities.

Shivaji College instituted Jijabai Achievers' Awards in

2010 to felicitate individuals who contribute either directly in changing lives of women, or indirectly by being the change themselves and becoming an inspiration to others. In the previous academic session, WDC organized a **National Seminar** on Women, Crime and Law: Protection or Assertion? The event was followed by presentation of Jijabai Achiever's Award and release of the book '**Utkarsha** -**Epitomizing Progress'**. WDC has appointed Dr. Kushal Kaushik, counselor, for students and staff of the college. She is available in the college on Monday and Friday between 12 noon to 2:00 pm.

Alumni Club

College has an active Alumni Club, a platform for institution to network and collaborate with former faculty and Alumni. Alumni members often help the placement cell of the college to connect with various companies. The association plans to introduce new scholarships for meritorious students and conduct interactive programmes for all students. This year the Club had organized an Alumni Meet in the month of May. The event was well attended and saw many Alumni Achievers sharing their experiences and memories.

It is made clear that if any false attestation/falsified record is detected, the student will be debarred from attending any course in the University or the College for the next five years and in addition, a criminal case under section of IPC will be instituted against him/her.

- 1. Online Registration
 - a. Candidates seeking admission to the Undergraduate (UG) Courses in different colleges of the University of Delhi are required to register online.
 - b. There is a common Web Portal for the centralized registration of candidates and a common registration form for admission to all the Undergraduate Courses in the University.
 - c. Online registration details are available on the following UG admission portal: http:// ug.du.ac.in
- 2. For courses where admissions are done through entrance examinations, separate procedures shall apply.
- 3. The procedure for calculation of Best of Four percentage (wherein admission is done on the basis of Best of Four) is outlined in Annexure-I.
- 4. Last date of admission for undergraduate courses will be 16th August 2016*.
- 5. The University reserves the right to initiate changes in the courses of study of the undergraduate courses.
- 6. The college will retain the certificates of approved candidate in order to avoid multiple admissions. The certificates will remain with the colleges during the admission process. However, the colleges shall promptly return the documents in case student withdraws/cancels the admission or student wishes to appear in counselling of any other university/ institute.
- 7. After this, the college will approve the admission on the UG admission portal. The candidate will then be required to log-on to the UG admission portal to make the online Admission Fee payment through one of the available online payment options. The approved candidate is permitted to make online admission fee payment till 12 noon of the next day of the given

admission list deadline (see Section 2.3).

- 8. It may be noted that your admission in a college is completed only after payment of the online admission fee on the UG admission portal within the prescribed time-limit.
- 9. A candidate can take admission only in one course in one college at any given time. In case a student wishes to withdraw/cancel the admission in a course/college, the candidate should approach the college where the admission is taken. Only after the college cancels the admission of a candidate, the candidate can proceed to take admission in other courses/ colleges. Admission fee will be refunded to the candidate as per the College/University rules.
- 10. The colleges shall admit all the candidates who meet the announced cut-off criteria. The policy will not be "first come first served."
- 11. The candidates who could not take admission in a given cut-off list can be considered for admission in the immediate next cut-off list only on the last date of admission, subject to availability of seats.
- 12. For Boards, like International Baccalaureate and others, whose results are declared late, candidates may be considered in whichever cut-off list their results are declared, subject to availability of seats and provided the candidate had completed the online registration process.
- 13. After five cut-off lists, the colleges will notify vacant seats course-wise and category-wise on the college and University websites. The registered candidates will be required to apply in the colleges/courses against vacant seats through the UG admission portal, using the subsequent procedure given in Section 2.4.
- 14. There shall not be any 'Additional Eligibility Criterion' for any category in any college/course.

The candidates seeking admission under Sports category may check the Section 9.7.2 and Annexure-IV for further details.

ADMISSION PROCESS AFTER FIFTH CUT-OFF LIST

If the seats remain vacant after fifth cut-off list, the admission process, as listed in Section 2.4, shall be followed to fill vacant seats (http//:ug.du.ac.in).

Admission Schedule of Children/Widows of eligible Armed Forces personnel (CW) can be checked from the University bulletin.

Girl students shall be given a 1% relaxation in cut-off for admission to all cources.

Procedure for calculation of 'Best of Four' subjects percentage for Honours Courses (For admission to Arts/ Humanities Courses):

- a. One Language (Core/Elective/Functional)
- b. The subject in which admission is sought (If a candidate does not include the concerned subject whether studied or not in Best Four in which he/she is seeking admission i the honours course, then a disadvantage of 2.5% may be imposed on the calculated Best fo Four percentage).
- c. Any two other academic/elective subjects as per List A. (If a candidate doesn't include the subjects given in List A in Best of Four, then a disadvantage of 2.5% in Best of Four for each subject may be imposed).

List A

The following Discipline subjects offered by the University of Delhi for admission to undergraduate courses must be treated as Academic/Elective subjects for the purpose of undergraduate admissions. All other subjects offered by different boards may be treated as non-elective. All the Discipline subjects must have at least a 70% component of theory exams (theory exam does not include internal assessment/continuous evaluation etc.) in the qualifying exam for the purpose of being treated as academic/elective subject.

- 1. *Accountancy will be treated as equivalent to commerce wherever any board is not offering commerce as a subject.
- 2. Biology/Biotechnology and Business Studies will be treated as academic/elective subjects.
- 3. #Music, and #Physical Education will be treated as academic/elective only for Honours in Music and Physical Education, respectively.
- 4. In case a candidate has studied both elective and core in any languages, then core language will be treated as language, while elective language can be considered as academic/elective subject.
- Admission to B.A. (Hons) Hindi Patrakarita and B.A. (Hons.) Journalism will be based on 'Best of Four' Percentage as in B.A. (Hons.) Hindi and B.A. (Hons.) english, respectively.
- 6. Admission to B.A. (Hons.) Applied Psychology

will be based on 'Best of Four' percentage as in B.A. (Hons.) Psychology.

- The subject 'Informatics Practices' will be equivalent to Computer Science for admission to B.Sc. (Hons.) Computer Science only.
- 8. The candidates must have studied and passed Mathematics at the qualifying exam for admission to Honours in Economics and Commerce.
- Business Mathematics will be treated as equivalent to Mathematics for admission to B.Com (H)/ B.Com only.
 - a. For admission to Honours in any language course, advantage of 2% in the Best of Four percentage may be given to those candidates who have studied the elective language.
 - b. In case, a candidate has not studied the language at qualifying exam and is seeking admission to Honours in that language, he/she

may be given a disadvantage of 5% in Best of Four percentage.

- c. For admission to Honours in English and Hindi, the candidate must have studied and passed the respective language in the qualifying exam and has to be included for calculation of Best of Four percentage.
- University may define any other relevant subjects as academic/elective for a particular Honours course.

Procedure for Calculation of 'Best of Four' subjects percentage for B.A. (Prog.)/B.Com (Prog.)

- a. One Language (Core/elective/Functional)
- Any three elective subjects can be chosen. A disadvantage of upto 5%* on Best of Four percentage may be imposed if there is a change of stream.
- c. for admission to B.A. (Vocational) only, related

vocational subjects may be treated at par with academic/elective subjects.

d. If a candidate opts for MIL (Except Hindi) as a subject, an advantage of up to 10% may be given in Best of Four in those colleges where MIL is offered as a subject.

*The college will have to notify the actual deduction upto 5% before hand by uploading on their website and intimating the same to the University.

Admission to Science Courses

The Basis of Selection for Mathematical Sciences/ Science/Home Science courses is listed in Section 5.3. All the subjects to be included for Basis of Selection (PCM/PCB/PCMB) must have at least 70% theory component of exam. In case, the subject to be considered does not have 70% theory component and 30% practical component, then the marks of theory and practical only must be converted to 70% and 30%, respectively on pro rata basis. These new marks will then be considered for calculation of PCM/ PCB etc.

1. Qualifying Examinations

Qualifying examinations for the purpose of admission to first year of undergraduate courses offered by the University shall be Senior Secondary School Certificate Examination (Class XII) of the Central Board of Secondary Education or an examination recognized as equivalent thereto. Candidate seeking admission to the courses offered by the University should have passed the qualifying examination obtaining minimum marks as specified for each of the courses.

2. Age Requirement

There is no minimum age bar for admission to undergraduate courses in the University/colleges except in professional courses where regulatory body prescribes minimum age requirement (such as MCI, AICTE etc.)

(Ordinance I).

Gap year(s) would be no bar for purposes of admission to the undergraduate courses.

3. Equivalence Criteria

The applications for admission to the Undergraduate courses in the colleges in respect of candidates belonging to the Examining bodies of Boards/Universities recognized/ accredited by the Association of Indian University/ University Grants Commission/Ministry of Human Resource Development shall be considered by the College/ Department in terms of the following recommendations as circulated in the University circular letter of 13-1-2005.

That various degrees from Universities recognized by the Association of Indian Universities / University Grants Commission / Ministry of Human Resource Development or by any bilateral agreement be considered as equivalent to corresponding degrees of University of Delhi subject to the conditions that course duration is same as in Delhi University for purposes of determining eligibility for admission to various courses and further Departments / Colleges may be allowed to evolve procedure through their respective Admission Committees.

Senior School Certificate of various Boards recognized by Association of Indian Universities/Central Board of Secondary Education, be considered as equivalent to the Senior School Certificate of Central Board for purposes of eligibility to various Undergraduate Courses.

Students who pass various Degree/School Examination of Foreign Universities/Boards as have already been approved by the Equivalence Committee, from time to time, be considered eligible as a matter of routine. The cases of only those candidates who do not fall in the list of Association of Indian Universities/University Grants Commission/ Ministry of Human Resource Development recognized accredited Boards/Universities shall be referred to the University on the basis of individual merit.

The admission in any course shall not be granted on predicted scores.

4. Gap Year

Students who have a gap in their education must bring the original documents such as admission slips, admit cards for any examination taken or certificates of courses attended in the gap period to be eligible for admission to the undergraduate course for which they qualify. Such students should meet the Convener of Admissions.

In such cases, candidate must submit:

- Affidavit from Court (Notary).
- Grade Conversion [As per AC Resolution No. 319, Dt. 22-3-1976], refer to the admission bulletin for further details.
- Recent Character Certificate from Class-I Gazzetted Officer.

Reservation of Seats

- 1. Schedule Caste/Schedule Tribe Candidates
 - a. 22.5% of the total number of seats are reserved for candidates belonging to Scheduled Caste/ Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable, if necessary). However, if the seats remain unfilled, the same shall be left vacant.
 - Relaxation to the extent of 5% in the minimum marks will be given to the candidates belonging to Scheduled Caste and Scheduled Tribes to determine their eligibility and merit for admission to the course concerned.
- c. In case, after giving 5% relaxation, the reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill up all the reserved seats.(AC Resolution A88, 14.6.1983) (EC Resolution 157, 24121.2001).

Note: SC/ST students who get admission under open merit will not be included in the reserved quota i.e. 22.5%.

2. Other Backward Classes

- a. 27% of seats are reserved for OBC students who belong to the Non-Creamy Layer and whose castes appear in the Central list of the OBC.
- b. The OBC certificate should clearly mention the Non-Creamy Layer status of the candidate. The candidates are required to bring the latest Family Income Certificate (Financial Year 2015-16) or Affidavit (from Class-I Magistrate) as the case may be ensuring Non-Creamy Layer.
- c. If the OBC certificate is in the name of the parent of the candidate at the time of the admission, the following will apply:
- i. The candidate will have to submit a copy of receipt showing that he/she has applied for OBC Non-Creamy Layer Certificate in his/her own name.
- ii. The candidate will have to provide an undertaking stating that he/she will submit the OBC Non-Creamy Layer Certificate in his/her own name before last date of admission.
- d. OBC candidates shall be given a relaxation to an extent of 10% of the minimum eligibility marks prescribed for General Category candidates. For example, if the minimum-eligibility for admission to a course is 50% for the General Category candidates, the minimum eligibility for the OBCs would be 45% i.e. (50% less 10% of 50%).
- e. If the seats meant for OBC remain vacant on the last date for admission, the same will be filled up by other eligible candidates.

Note: The merit list for the general category seats will comprise of all the candidates in the order of merit. No one will be excluded from the same. In other words, it will also include SC/ST/OBC/PwD candidates (if they come in general merit). The candidate cannot be excluded from the general category merit list just because he belongs to SC/ST/OBC/PwD. Such a candidate is entitled to be considered under the general category, as well as under the reserved category. Admission to open category seats will be strictly in the order of merit without excluding SC/ST/OBC/PWD candidates.

- 3. PwD/Armed Forces/Foreign Students/Sports*
 - a. 3% seats are reserved for candidates with physical disabilities with not less than 40% disabilities (1% seats are for persons with low vision or blindness, 1% for hearing impaired, 1% for those with loco motor disabilities and or cerebral palsy).
 - Note: Refer to the University's admission bulletin for regulations related to concession/waiver of fees regarding PWD.
 - b. 5% of the total seats are reserved for children/ widows of personnel of the Armed Forces including Paramilitary Forces killed or disabled in action or while on duty.
 - c. All foreign students, including those who have completed their schooling from an Indian Board may be treated as Foreign Students for the purpose of their registration / admission in various departments and Colleges of the University and they may be considered for admission under 5% quota prescribed for the foreign students.

Registration of Kashmiri Migrants

(Refer to http//:ug.du.ac.in)

- 1. A concession of maximum 10% in the last cut-off marks fixed for General category candidates shall be extended to the Kashmiri Migrants.
- 2. Admission of Wards of Kashmiri Migrants will be based on cut-offs to be announced by the Colleges.

(The candidates selected under special Scholarship Scheme for J&K will be admitted directly to colleges)

- 3. Not more than 5% sports quota (subject- wise) be continued. The College is free to decide the actual number of seats to be filled on sports basis (not more than 5%) keeping in view the facilities available, requirement of the College and other relevant factors.
- 4. *Admission in these categories shall be made in accordance with guidelines issued by the University from time to time. For more details refer to Delhi University Website (http://:ug.du.ac.in).

The College admits the students to M.A. courses in Hindi, Political Science and Sanskrit. Candidates will be registered by the University for admission to these courses. Application for M.A. courses will be received by the college immediately after the University issues the list of candidates selected for admission.

OUTLINE OF CHOICE BASED CREDIT SYSTEM

- 1. Core Course: A course, which should compulsorily be studied by a candidate as a core requirement is termed as a Core course.
- 2. Elective Course: Generally a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline/ subject of study or which provides an extended scope or which enables an exposure to some other discipline/subject/domain or nurtures the candidate's proficiency/skill is called an Elective Course.
 - 2.1 **Discipline Specific Elective (DSE) Course:** Elective courses may be offered by the main discipline/subject of study is referred to as Discipline Specific Elective. The University/Institute may also offer discipline related Elective courses of interdisciplinary nature (to be offered by main discipline/subject of study).
 - 2.2 **Dissertation/Project:** An elective course designed to acquire special/advanced knowledge, such as supplement study/support study to a project work, and a candidate studies such a course on his own with an advisory support by a teacher/faculty member is called dissertation/project.
 - 2.3 Generic Elective (GE) Course: An elective course chosen generally from an unrelated discipline/ subject, with an intention to seek exposure is called a Generic Elective.
 - P.S.: A core course offered in a discipline/subject may be treated as an elective by other discipline/subject and vice versa and such electives may also be referred to as Generic Elective.
- 3. Ability Enhancement Courses (AEC): The Ability Enhancement (AE) Courses may be of two kinds: Ability Enhancement Compulsory Courses (AECC) and Skill Enhancement Courses (SEC). "AECC" courses are the courses based upon the content that leads to Knowledge enhancement; i. Environmental Science and ii. English/MIL Communication.

These are mandatory for all disciplines. SEC courses are value-based and/or skill-based and are aimed at providing hands-on-training, competencies, skills, etc.

3.1 Ability Enhancement Compulsory Courses (AECC): Environmental Science, English Communication MIL Communication.

3.2 **Skill Enhancement Courses (SEC):** These courses may be chosen from a pool of courses designed to Wprovide value-based and/or skill-based knowledge.

All India entrance scholorship by the university of delhi

Delhi University holds a competitive examination in the month of October each year for the award of All India Entrance Scholorship of Rs 250/- per month, each tenable for three years. Any Honours course student with at least 55% marks in the aggregate may apply along with the examination fees of Rs 50/- in the prescribed from which can be obtained from the Examination Branch of the University of Delhi.

Fee Concession Committee

The college grants fee concession ranging from 10-100% of the fee. This is done through the Fee Concession Committee (F.C.C.) which invites applications from students and then reviews them. The concession is granted on the basis of the economic status of the students' family and the academic provess of the student. Its continuance depends upon satisfactory academic progress, regular attendance and good conduct. Students of self financing courses like BBE are not considered for grant of concession.

Student Union Advisory Committee

The Student Union Advisory Committee of the college has been formed to promote mutual contact, a democratic outlook and a spirit of camaraderie among the students of the college. The committee works to nurture social, cultural and intellectual development of students. It tries to create consciousness among students of the college regarding events taking place around them, with a view to educate them as responsible citizens and to build up a healthy students' movement. The committee has regular interactions with the student representatives to discuss matters concerning them. The aim of the Committee is to maintain peace, discipline, law and order in the college campus.

Placement Cell

Shivaji College has a very active placement cell that works round the year to provide internship and employment opportunities to its students. The cell also organizes skill development workshops, seminars and talks that give students ample insight into scenario prevailing in the current job market. Students can register themselves for placements/internships through the college website. It also has a page on popular social networking site Facebook through which information regarding cell's activities is disseminated to students. The cell also coordinates with the Central Placement Cell of the University of Delhi to ensure that students also have an access to placements/internships opportunities provided by companies that visit the University Campus.

ORDINANCE XV-B: Maintenance of Discipline among Students of the University

- 1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance, the following shall amount to acts of gross indiscipline:
- physical assault, or threat to use physical force, against any member of the teaching and nonteaching staff of any Institution/Department and against any student within the University of Delhi;
- carrying of, use of, or threat to use of any weapons;
- any violation of the provisions of the Civil Rights Protection Act, 1976;
- violation of the status, dignity and honour of students belonging to the scheduled castes and tribes;
- any practice-whether verbal or otherwisederogatory of women;
- any attempt at bribing or corruption in any manner;
- wilful destruction of institutional property;
- creating ill-will or intolerance on religious or communal grounds;
- causing disruption in any manner of the academic functioning of the university system;
- ragging as per Ordinance XV-C.
- 4. Without prejudice to the generality of his/ her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/ her appropriate, the Vice-Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students-
- be expelled; or
- be, fora stated period rusticated; or

- be not for a stated period, admitted to a course or courses of study in a College, Department or Institution of the University; or
- be fined with a sum of rupees that may be specified; or
- be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or
- the result of the student or students concerned in the Examination or Examinations in which he/she or they have appeared be cancelled.
- 5. The Principals of the Colleges, Heads of the Halls, Deans of Faculties, Heads of Teaching Departments in the University, the Principal, School of Correspondence Courses and Continuing Education and Librarian shall have the authority to exercise all such disciplinary powers over students in their respective Colleges, Institutions, Faculties and Teaching Departments, in the University as may be necessary for the proper conduct of the Institutions, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to, such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
- 6. Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules.
- 7. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and the several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the Rules that have been framed there under by the University.

ORDINANCE XV-C: Prohibition of and Punishment for Ragging

- Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students and includes individual or collective acts or practices which-
- involve physical assault or threat to use of physical force;
- violate the status, dignity and honour of women students;
- violate the status, dignity and honour of students belonging to the scheduled castes and tribes;
- expose students to ridicule and contempt and affect their self esteem;
- entail verbal abuse and aggression, indecent gestures and obscene behaviour.
- 4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, of University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging.
- 5. Notwithstanding anything in Clause (4) above, the Proctor may also suo moto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied

that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.

- When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final. The relevant authority under Clause (7) disclosing the occurrence of ragging incidents described in Clause 3 (a), (b) and (c) the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause(7) disclosing the occurrence of ragging incidents described in Clause 3 (a), (b) and (c) the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Vice-Chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
- 11. In case any students who have obtained degrees of Delhi University are found guilty under this Ordinance appropriate action under Statute 15 for withdrawal of degrees conferred by the University shall be initiated.
- 12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.
- 13. All institutions within the Delhi University system shall be obligated to carry out instructions/ directions issued under this Ordinance, and to give aid and assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

THE SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL)

Act, 2013 (MINISTRY OF LAW AND JUSTICE)

ORDINANCE XV-D

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto.

WHEREAS sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment;

AND WHEREAS the protection against sexual harassment and the right to work with dignity are

universally recognized human rights by international conventions and instruments such as

Convention on the Elimination of all forms of discrimination against Women, which has been

ratified on the 25th June, 1993 by the Government of India.

AND WHEREAS it is expedient to make provisions for giving effect to the said Convention

for protection of women against sexual harassment at workplace.

ORDINANCE VIII-E: Internal Assessment*

 The scheme for Internal Assessment shall be followed in the regular stream only, with exclusions as per the Appendix of Information Bulletin of University of Delhi and is applicable to the students admitted from the academic session 2003-04 onwards in both undergraduate and postgraduate degree courses. This scheme of Internal Assessment shall not be applicable to the School of Open Learning and Non-Collegiate Women's Education Board.

- 2. The specific Ordinances pertaining to schemes of examinations of various courses shall stand amended, mutatis mutandis, to the extent of internal assessment as laid down in this Ordinance, subject to exclusions referred to above.
- 3. Internal Assessment marks shall be shown separately in the Marks Sheet issued by the University and these marks shall be added to the annual/semester examination marks for determining the division of the student.
- 4. 25% of the maximum marks in each paper in
- 5. undergraduate courses shall be assigned for Internal Assessment and the remaining 75% marks for the annual/semester University Examination; the time duration and other modalities of the annual/semester Examination with respect to this 75% component shall remain as per existing schemes of examination for various undergraduate courses.
- 6. For the Annual Examination Scheme, there shall be 10% weightage assigned to House Examinations to be conducted by each college, forall subjects in B.A., B.Com. and B.Sc. courses and all papers of the Main Subject in Honours courses. For the Semester Examination Scheme, there shall be 10% weightage assigned to Class Test(s)/Quiz(s) to be conducted by each college, for all subjects in B.A., B.Com. and B.Sc. courses and all papers of the Main Subject in Honours courses.
- 7. Each student shall be assessed on the basis of written assignments/tutorials as well as on the basis of project reports/term papers/seminars. There shall be 10% weightage for such written assignment; and project reports/presentations/

term papers/seminars. Each student shall be given at least one written assignment per paper in each term / semester.

8. There shall be 5% weightage for regularity in attending lectures (including interactive periods) and tutorials, and the credit for regularity in each paper, based on attendance, shall be as follows:

More than 67% but less than 70% -1 mark 70% or more but less than 75% - 2 marks 75% or more but less than 80% - 3 marks 80% or more but less than 85% - 4 marks 85% and above - 5 marks*

- 9. [Medical certificates shall be excluded while calculating credit towards marks to be awarded for regularity, though such certificates shall continue to be taken into account for the purpose of calculating eligibility to appear for examinations as per the existing provisions of Ordinance V11.2.9.(a) (ii).]
- 10. The promotion criteria shall be as per the existing Ordinances for University Examinations, as applicable to respective courses. In addition, the same criteria shall apply to the total of the University Examination and the Internal Assessment, taken together.

11. Pass Percentage & Promotion Criteria

- 12. The minimum marks required to pass any paper in a semester shall be 40% in theory and 40% in Practical, wherever applicable. The student must secure 40% in the End Semester Examination and 40% in the Total of End Semester Examination & Internal Assessment of the paper for both theory & practical separately.
- 13.A student shall be eligible for promotion from 1st year to 2nd year of the course provided she/he has passed 50% papers of I and II semester taken together.
- 14. Similarly, a student (irrespective of Part I results) shall be eligible for promotion from 2nd year to 3rd year of the course provided she/he has passed 50% paper of III and IV semesters taken together
- 15.4.1.4 Students who do not fulfil the promotion

criteria (b) & (c) above shall be declared fail in the Part concerned. However, they shall have the option to retain the marks in the papers in which they have secured Pass marks as per Clause (a) ab ove.

- 16.A student who has to reappear in a paper prescribed for Semester I/III V may do so only in the semester examinations to be held in November/ December. A student who has to reappear in a paper prescribed for Semester II/IV/VI may do so only in the examination to be held in April/May.
- 17. Reappearance in passed papers:
- 18. A student may reappear in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (for example, a student reappearing in a paper prescribed for Semester I examination, may do so along with subsequent Semester III examination and not along with papers for Semester V).
- 19. A candidate who has cleared the papers of Part III (V & VI Semester) may reappear in any paper of V or VI Semester only once, at the immediate subsequent examination on foregoing in writing her/his previous performance the paper/s concerned, within the prescribed span period.
- 20. (Note: The candidate of this category will not be allowed to join any postgraduate courses)
- 21. In the case of reappearance in a paper, the result will be prepared on the basis of candidate's current performance in the examination.
- 22. In the case of a candidate, who opts to re-appear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reappear in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to re-appear shall be taken into account while determining her/his result of the examination held currently.
- 23.Reappearance in Practical examinations shall not be allowed.

*The College follows and implements the rules regarding attendance in a strict manner.

- 24.A student who reappears in a paper shall carry forwarded the internal assessment marks, originally awarded.
- 25. Division Criteria: A student who passes all the papers prescribed for Semester I to Semester VI examinations would be eligible for the degree. Such a student shall be categorized on the basis of the combined result of Semester Ito Semester VI examinations as follows:-
- 26.60% or more First Division
- 27.50% more but less than 60% Second Division
- 28.40% more but less than 50% Third Division
- 29. In the case of a student who is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defence work and allied duties, or in the case of a student who is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Head of the institution concerned, or a student who is selected to participate in sports or other activities organized by the Inter-University Board or in national or international fixtures in games and sports approved by the Vice- Chancellor, or a student who is required to represent the University at the Inter-University Youth Festival, or a student who is required to participate in periodical training in the Territorial Army, or a student who is deputed by the College to take part in Inter-College sports, fixtures, debates, seminars, symposia or social work projects, or a student who is required to represent the College concerned in debates and other extracurricular activities held in other Universities or such other activities approved by the Vice- Chancellor, the following provision will apply :
- 30. A student in the categories listed above, will have to fulfil the requirement of written assignments and projects/term papers/seminars/field-work with the flexibility, however, that he/she may, if necessary, be allowed additional time for submission of written assignments.

- 31.A student in the categories listed above, who is unable to write the House Examination / Class Test(s)/Quiz(s) on account of his/her participation in such aforesaid activities, may be assessed by the College through an alternative mode. This may be done only in exceptional circumstances.
- 32. A student in the categories listed above, will get the benefit of attendance for Internal Assessment for the classes missed as per the existing provisions of Ordinance VII.2.(9)(a)(i) (refer to 'www. du.ac.in').
- 33. The University reserves the right to review, and if necessary moderate the marks in Internal Assessment in any paper/ papers in any College/ Department. The information provided here is to the best of our knowledge. For further information please refer to the University website www.du.ac. in.

Ordinance VII: Conditions for Admission to Examinations*

Ordinance VII 2.(2)

34. Every student is supposed to attend not less than twothirds of lectures and practicals delivered in the college separately for his course of study in each academic year.

Ordinance VII 2.(9)(a)(ii)

35. The Principal of the College may consider. on the basis of the Medical Certificates produced. exceptional cases of students who had fallen seriously ill or had met with an accident with a view to determining whether the lectures etc. delivered during the said period, or a part thereof, could be excluded for purposes of calculation of attendance of the year and decide each case on its own merit.

Ordinance VII 2.(9)(c)

36. The benefit of exclusion of lectures contemplated in Ordinance V112. (9) a (i) above, either separately or jointly, shall in no case exceed 1/3rd of the total number of lectures delivered. For further clarity Ordinance VII should be consulted.
