

3. The appointment is further subject to the verification of your qualification/ SC/ ST/ OBC & PH etc. certificates.
4. You are further advised to contact the Section Officer (Accounts) in the College for the purpose of opening a Saving Bank Account at the Central Bank of India, Shivaji College Branch, Raja Garden, New Delhi - 110027.
5. For the purpose of claiming House Rent Allowances exemption, please apply for the same to the Section Officer (Accounts) and submit Rent Receipt/ Application within 10 days from the date of your joining in the college.
6. The appointment is purely on adhoc basis w.e.f. 21.07.2014 to 20.11.2014 or till the appointment permanent incumbent, whichever is earlier. **This appointment may be terminated with a notice of 24 hours from either side.** Further, your appointment is subject to the ultimate result of the writ petition (Civil) No. 803/2014 filed by Delhi University SC/ST/OBC teachers forum and others v/s. University of Delhi before the Hon'ble Delhi High Court and approval of the Governing Body of the College.
