EXTRACT OF GOVERNING BODY MEETING MINUTES HELD ON
17.05.2017: -

ITEM NO. 5:

To report the request of Dr. Sarvesh Kumar Dubey for institution of scholarship to
M.A. (Hindi) students

It is submitted that the Governing Body in its meeting dated 25.05.2016 **appreciated the gesture of Dr. Sarvesh Kumar Dubey** on the receipt of a cheque, amounting to Rs. 25000/- from him for institution of scholarship to that M.A. (Hindi) student who gets highest marks in the Final Year. He made a request to initiate the process (felicitation in the name of his father Late Dr. Bhagwat Prasad Dubey) from the Academic Session 2016-17 and assured to provide more funds in near future, if needed.

Nevertheless, the Governing Body decided in its referred meeting that a minimum amount of Rs. One lac be deposited to institute an award in the name of an entity and less than Rs. One lac may be deposited in Common Welfare Fund created by the College for poor/ needy students.

The above decision was conveyed to him and now the College is in receipt of a cheque, amounting to Rs. One Lac from Mr. Sarvesh Kumar Dubey but this time, he made a request for institution of scholarship to M.A. (Hindi) student in the same manner as stated above but felicitation should be in his own name i.e. 'Dr. Sarvesh Kumar Dubey Cash Prize Award'.
