The parties confirm that the ownership and title to the Equipment is and shall at all times remain vested in and belong to MBL and MBL has the right of inspection and physical verification of the Equipment. The College would ensure that the safeguarding of the Equipment is maintained. College agrees and confirms to execute the necessary bailment and equipment placement agreement

- 2 The College at no point of time shall sell, lease let out on rent, pledge, hypothecate, mortgage, dispose off to any third person or part with the possession of the Equipment in any manner whatsoever.
- 3 No other co-sponsor of the College to put up more than 10 banners each at the venue. Both the parties will mutually decide to allow/disallow credits of co-sponsor on all written material/collateral.

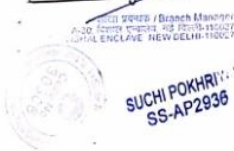

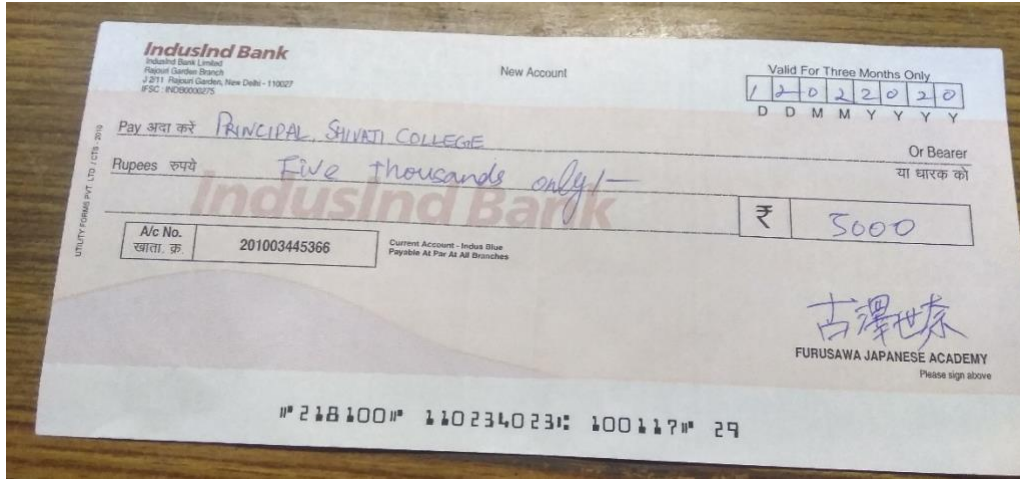
