



MEMORANDUM OF UNDERSTANDING ON ACADEMIC AND RESEARCH COOPERATION

and

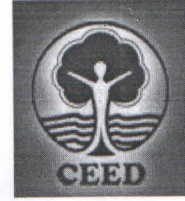
CENTRE FOR ENVIRONMENT AND ECONOMIC DEVELOPMENT, CEED NEW DELHI

Shivaji College, University of Delhi, Delhi, India, represented by the Principal Dr. Shiv Kumar Sahdev, hereafter referred to as Shivaji College, and **Centre for Environment and Economic Development (CEED) New Delhi**, India, represented by the President, Dr. Ashutosh Mohanty hereafter referred to as CEED considering their common interest in promoting the mutual cooperation in the area of education and research, both parties, therefore, wish to expand the basis for friendship and cooperative educational exchange, and have set forth the following Memorandum of Understanding (MOU):

The purpose of this MOU is to develop academic and educational cooperation on the basis of equality and reciprocity and to promote relations and mutual understanding between Shivaji College and CEED.

Both parties undertake to promote and develop academic cooperation as follows:

1. Cooperation in research and the presentation of its results.
2. Exchange of academic materials, publications and other scientific information.
3. Collaboration in the area of library and other auxiliary services.
4. The parties will share all data and research findings, patent rights, copyrights, and other intellectual property rights to any discoveries, inventions and products resulting from this MOU.
5. Both parties must give written approval for the utilization and publication of the data and research findings.
6. Detailed management of the Intellectual Property Rights and Publication shall be defined in the Agreement of Implementation of each activity.
7. The differing viewpoints and interpretations of this MOU shall be settled amicably by mutual consultation or negotiation.
8. This MOU shall be in effect from the date of its signing and be valid for the duration of five (5) years from that date, unless terminated or replaced with a new MOU.
9. Jointly organizing national and international trainings and applied projects with use of best available human and knowledge Resources as well as on and off the campus.
1. This MOU may be terminated by either party by written notice at least six (6) months in advance. Such notice of termination will not interfere with cooperative programs currently underway. Such programs will be allowed to continue until their conclusion.
