

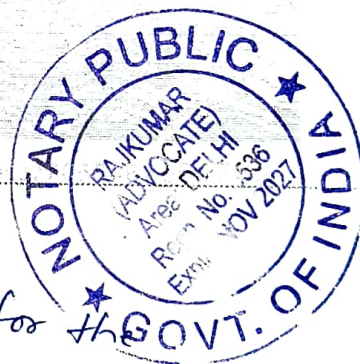

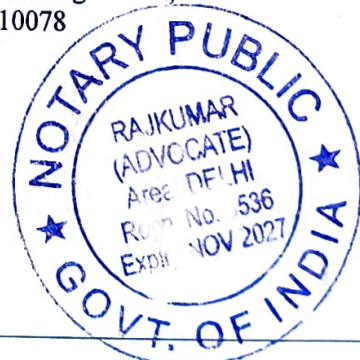

MEMORANDUM OF UNDERSTANDING (MOU)

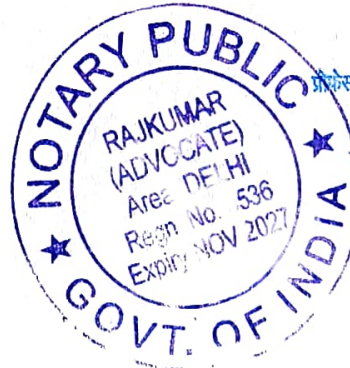
The Memorandum of Understanding is signed on 27/3/2025

5. **VAIDEHI** – Empowering Women through Skill Development, Capacity-Building programs, and initiatives that promote gender equality and self-sufficiency.
6. **SAMADHAN** – Advocating for Environmental Rights and Consumer Protection by driving Policy Discussions, Legal Awareness, and Sustainable Solutions.
7. **DRITI** – A Climate Resilience and Sustainability Initiative aimed at redesigning and innovating activities for long-term environmental and social impact.

PURPOSE:

The Parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the purpose of promotion and understanding of high performance in awareness activities and organizing various programs including internships, conferences, workshops, outreach activities and other awareness programs. The purpose of this MoU is to define the areas for fundamental, Socio-academic aspects in which the Parties desire to work together in the future for their mutual benefit to foster a collaborative frame work between Shivaji College and Lakshya – A Society for Social and Environmental Development in the field with a view to benefiting from each other's initiatives and working procedures and to support collaboration among the members associated with both Parties.

SCOPE:

This MoU sets forth the intentions of the Parties for increased collaboration, cooperation and interaction and does not create any legally binding commitments. If the Parties later agree to undertake specific joint projects with legally binding obligations, they will develop separate written agreements for such projects, setting out each Party's contributions, deliverables. The parties will cover the topics written below:

1. Gender Equity: seminar, awareness program, focused group discussion etc.
2. Environmental Consciousness and Sustainability include
 - Alternate sources of energy and energy conservation measures
 - Management of degradable and non-degradable waste and E-waste management program
 - Water conservation
 - Green campus
 - Organize outreach activities, workshops, and awareness programs to sensitize the students about sustainability.



- Tree plantation program
- Help and motivate students for taking part in debate on various environmental issues before the national/global platform
- 3. Quality audits on environment and energy
- 4. Disabled-friendly, barrier free environment
- 5. Inclusion and Situatedness
- 6. Human Values and Professional Ethics
- 7. Celebration/ organization of national & international commemorative days, events and festivals.

THE PARTIES INTEND TO:

- Strengthen the ties between Lakshya – A Society for Social and Environmental Development and Shivaji College to make collaborative efforts in the field of Environmental Awareness.
- Collaboration in Awareness campaigns and other field of mutual interest.
- Engage students and scholars in internship programs
- Provide free of cost mutual access to facilities available for the purpose of Awareness Programs.

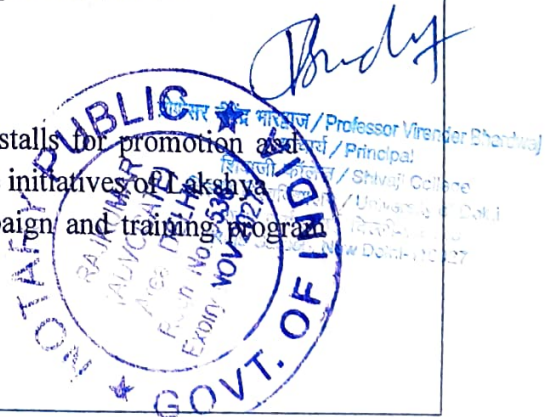
This MOU is signed between Shivaji College and Lakshya – A Society for Social and Environmental Development for the following deliverables.

Deliverables from the Lakshya

2. Providing platform to our students to undergo short projects and internship programs under Lakshya – A Society for Social and Environmental Development

3. Logo on all online and offline modes of promotion of the event jointly organized by the college and Lakshya

MODE OF OPERATION:

Both parties will provide necessary support for effective implementation of the MoU within the institutional rules and procedures. This MoU shall be effective from the date it is signed by both the parties. Within the broad frame work of the MoU, Shivaji College (University of Delhi), New Delhi and Lakshya – A Society for Social and Environmental Development, Delhi can work on awareness activities, internship programs, development of facilities etc.

Any financial commitment for joint activities under this MoU shall be subject to the approval by the Competent Authorities of the respective organizations. The activities under this MoU shall be coordinated, monitored and recorded by an Internal Coordination Committee, President, Lakshya, shall be internal coordinator from Lakshya – A Society for Social and Environmental Development, whereas the Principal, Shivaji College will be the internal coordinator and competent authority from Shivaji College. The visitors will be bound by the rules and regulations, as well as the code of conduct of the host institution.

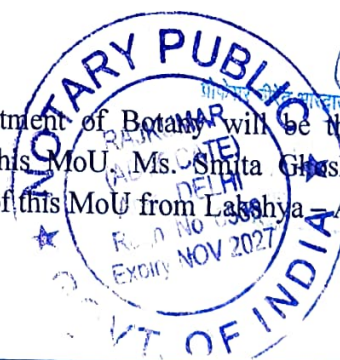
FINANCIAL IMPLICATIONS:

This MoU places no financial obligations or supplementary funding commitments on either party. These activities will be defined through separate program agreement, detailing the commitment of resources (financial or otherwise) required from each institution. Subsequent program agreements must be approved in advance in writing by the authorized representatives from both Parties. Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU. Where possible and appropriate, the parties may also seek funding for collaborations from Government and related agencies.

This MoU is also on broad based understanding between the parties and does not place any financial liabilities on any of the parties. In case there is joint financial involvement between both the parties for any awareness activities it would be decided on event basis in advance.


