Dear Madam/ Sir,

The Swachhata Hi Seva Campaign in 2024 witnessed tremendous response from all quarters of society, bringing together diverse stakeholders, especially HEIs, in reaffirming our commitment to Sampurna Swachhata. Continuing this tradition, I am writing to seek your whole-hearted support and enthusiasm in organising the '**Swachhata Hi Sewa 2025**' (SHS 2025) campaign to be observed from 17th September to 1st October, 2025 with the theme of '**Swachhotsav**'. This will culminate in the Swachh Bharat Diwas celebrations on 2nd October, 2025. A DO letter dated 4th September, 2025 from Secretary, D/o Drinking Water and Sanitation (D/o DWS) and Secretary, M/o Housing & Urban Affairs (MoHUA) in this regard is enclosed for perusal.

2. The SHS 2025 campaign is to be carried out using the '**Whole of Society**' and '**Whole of Government**' approach and will have the following key focus areas :-

i. **Transformation of Cleanliness Target Units (CTUs)**: Wherein difficult and dirty spots will be identified, mapped and cleared in the time bound manner,

ii. **Clean Public Spaces**: General cleanliness of establishments / institutions and high footfall spaces,

iii. **SafaiMitra Suraksha Shivirs** - Single window camps for preventive health checkup and linking with welfare schemes,

iv. **Clean Green Utsav**: Eco - friendly and zero waste celebration,

v. **Advocacy**: Swachh Sujal Gaon, Waste to Art, Clean Street Food, RRR Centers etc.

3. Building on the success of previous years where crores of citizens participated, we invite you to join the nationwide shramdaan '**Ek Din, Ek Ghanta, Ek Saath**' is proposed on September 25th, 2025. Let us once again unite for one hour of voluntary cleanliness service to make a significant difference."

4. Daily reporting of activities during SHS-2025 are to be uploaded on daily basis on the specially curated IT Portal for SHS-2025 (<https://swachhatahiseva.gov.in/>). Details and login credentials will be shared subsequently, followed by IT trainings for local bodies, PSUs and Central Ministries and other stakeholders.

In order to familiarise participating stakeholders with the workflow in the IT portal for SHS 2025, DoDWS and MoHUA will be conducting training sessions in the coming days and link for the same will be communicated shortly. Meanwhile, I would request you to nominate a senior official to coordinate and monitor the activities planned under SHS 2025, including identification and transformation of CTUs, at the earliest. 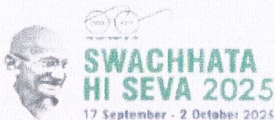
मेरा मानना है कि दुनिया के देश जो साफ़ दिखते हैं वो इसलिए हैं क्योंकि उनके नागरिक
